## Scott A. Snyder

Scott A. Snyder is senior fellow for Korea studies and director of the program on U.S.-Korea policy at the Council on Foreign Relations (CFR).

Mr. Snyder served as an adjunct fellow at CFR from 2008 to 2011 and as project director for CFR's Independent Task Force on policy toward the Korean Peninsula. He is the author of many books and articles on aspects of Korean politics and foreign policy, including the forthcoming *The United States-South Korea Alliance: Why It May Fail and Why It Must Not* (December 2023), *South Korea at the Crossroads: Autonomy and Alliance in an Era of Rival Powers* (January 2018), *Domestic Constraints on South Korea Foreign Policy* (with Geun Lee, Young Ho Kim, and Jiyoon Kim, January 2018), *The Japan-South Korea Identity Clash: East Asian Security and the United States* (with Brad Glosserman, May 2015), *China's Rise and the Two Koreas: Politics, Economics, Security* (January 2009), and *Negotiating on the Edge: North Korean Negotiating Behavior* (November 1999). He is also coeditor of *North Korean Foreign Policy: The Kim Jong-Un Regime in a Hostile World* (January 2023) and *North Korea in Transition: Politics, Economy, and Society* (October 2012), and the editor of *Middle-Power Korea: Contributions to the Global Agenda* (June 2015), *Global Korea: South Korea's Contributions to International Security* (October 2012) and *The U.S.-South Korea Alliance: Meeting New Security Challenges* (March 2012). He currently writes for the CFR blog, *Asia Unbound.* 

Prior to joining CFR, Mr. Snyder was a senior associate in the international relations program of the Asia Foundation, where he founded and directed the Center for U.S.-Korea Policy and served as the Asia Foundation's representative in Korea (2000–2004). He was also a senior associate at Pacific Forum Center for Strategic and International Studies. Mr. Snyder has worked as an Asia specialist in the research and studies program of the U.S. Institute of Peace and as acting director of Asia Society's contemporary affairs program. He was a Pantech visiting fellow at Stanford University's Shorenstein Asia-Pacific Research Center during 2005–2006, and received an Abe fellowship, administered by the Social Sciences Research Council, in 1998–1999. Mr. Snyder has provided advice to nongovernmental and humanitarian organizations active in North Korea and serves on the advisory council of the National Committee on North Korea.

Mr. Snyder received a BA from Rice University and an MA from the regional studies East Asia program at Harvard University. He was a Thomas G. Watson fellow at Yonsei University in South Korea.
