## **Antony J. Blinken**

Antony J. Blinken is the seventy-first U.S. secretary of state. He was nominated by President Biden on November 23, 2020; confirmed by the U.S. Senate on January 26, 2021; and sworn in by Vice President Kamala Harris the following day. Over three decades and three presidential administrations, Blinken has helped shape U.S. foreign policy to ensure it protects U.S. interests and delivers results for the American people. He served as deputy secretary of state for President Barack Obama from 2015 to 2017, and before that, as President Obama's principal deputy national security advisor. In that role, Blinken chaired the interagency deputies committee, the main forum for hammering out the administration's foreign policy. During the first term of the Obama administration, Blinken was national security advisor to then-Vice President Joe Biden. This was the continuation of a long professional relationship that stretched back to 2002, when Blinken began his six-year stint as Democratic staff director for the U.S. Senate Foreign Relations Committee, then-Senator Biden chaired the committee from 2001 to 2003 and 2007 to 2009. During the Clinton administration, Blinken served as a member of the National Security Council (NSC) staff, including two years as the senior director for European affairs, the president's principal advisor on the countries of Europe, the European Union, and North Atlantic Treaty Organization. He also spent four years as President Clinton's chief foreign policy speechwriter, and he led the NSC's strategic planning team. Blinken's public service began at the U.S. Department of State. From 1993 to 1994, he was a special assistant in what was then called the Bureau of European and Canadian Affairs. Outside of government, Blinken has worked in the private sector, civil society, and journalism. He was a founder of WestExec Advisors and was also a senior fellow at the Center for Strategic and International Studies from 2001 and 2002. Before joining government, Blinken practiced law in New York and Paris. He was also a reporter for the *New Republic* magazine and is the author of *Ally Versus Ally: America, Europe and the Siberian Pipeline Crisis*. He is a graduate of Harvard College and Columbia Law School.

## **Richard Haass**—presiding

Dr. Richard Haass, a veteran diplomat and respected scholar of international relations, is in his twentieth year as president of the Council on Foreign Relations. He previously served in the State Department under Presidents George W. Bush and Ronald Reagan, at the White House under George H.W. Bush, and the Pentagon during the Carter administration. He was U.S. envoy to the Cyprus negotiations and the Northern Ireland peace process, and after 9/11 was U.S. coordinator for the future of Afghanistan. Dr. Haass is the author or editor of fourteen books on American foreign policy, one book on management, and one on American democracy. His latest book, *The Bill of Obligations: The Ten Habits of Good Citizens*, was published by Penguin Press in January 2023 and became a *New York Times* best seller. He also authors a weekly newsletter, *Home & Away*, available on Substack. A Rhodes Scholar, Dr. Haass holds a bachelor's degree from Oberlin College, the doctorate of philosophy degree from Oxford University, and numerous honorary degrees. He is the recipient of the State Department's Distinguished Honor Award, the Presidential Citizens Medal, and the Tipperary International Peace Award. Dr. Haass, who was born in Brooklyn and grew up on Long Island, lives with his wife in New York City.
